## ENHANCING THE POLICY DEBATE WITH THE ACADEMIC WORLD

SUMMIT will encourage new and innovative angles in the debate on the European Council by bringing together academic experts, leading practitioners and the wider public in high profile international events. The kick-off conference will define the state of the art, underline the need of dealing more intensively with the Council European and discuss convenient methodology. The SUMMIT roundtable series will enable a debate among experts and the public on a European Council topic in selected European cities. Concluding the project, the results will be

presented at a dissemination conference.

#### NEW PERSPECTIVES AND A SUSTAINABLE PROVISION OF TEACHING AND STUDY MATERIAL

There has been research and teaching on the European Council. However, the heads of state or government's 'home institution' remains underresearched and is often regarded as an opaque 'club of bosses'. SUMMIT aims at bridging this gap between public understanding and existing insights and expertise.

The SUMMIT team will construct an informative and systematic platform containing online modules, including webcasts and guiz games, as well as overviews about important European Council topics, events and critical junctures. By pooling web links and introducing into decisive publications and information, SUMMIT will offer a comprehensive, innovative and intelligible approach to the subject. The project's results will be made available for an international public at www.summit.uni-koeln.de will constantly be updated.


